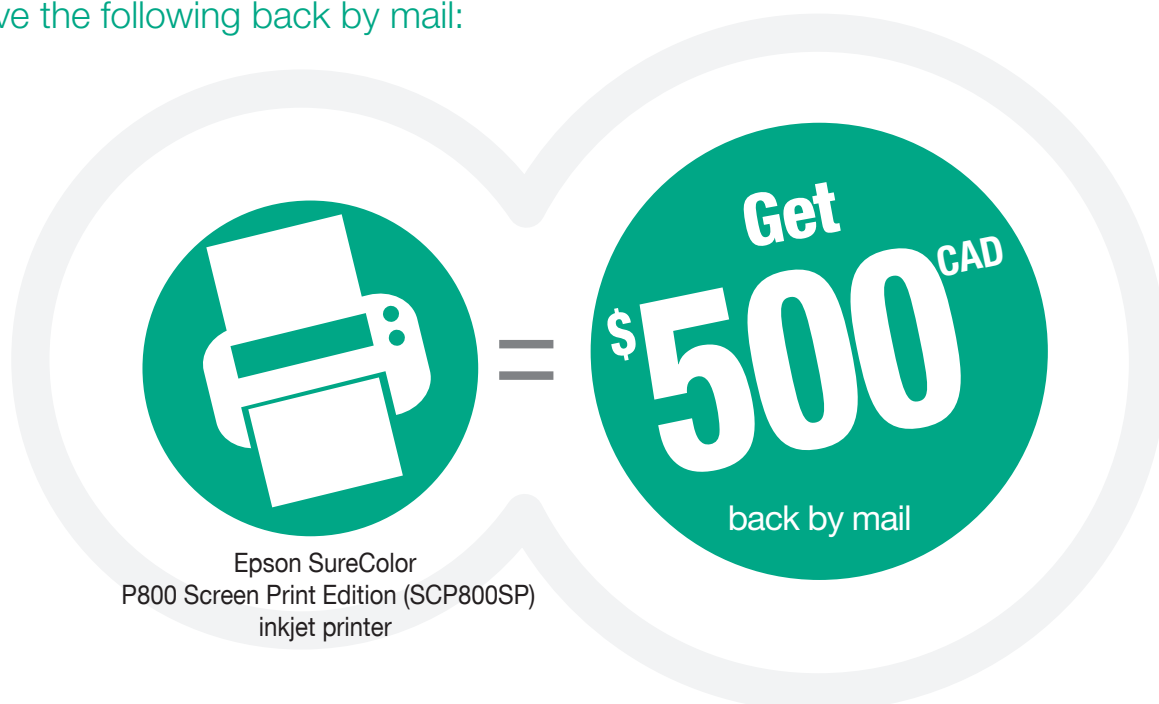


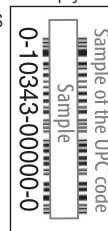
Mail-in rebate
