
Gift Redemption Procedure:

- 3. Email below complete materials to giftredemption@ehk.epson.com.hk within specified period:
 - a) Gift Redemption Form
 - b) Invoice copy of purchased products
 - c) Photo of serial number sticker on product body
 - d) Usage history sheet (Apply to L4160 and L5190 only)
- 4. Once approved as an eligible redemption application, gift(s) will be mailed to registered address within 45 days

Serial number sticker on product body sample




Usage history sheet sample
