Authorization depends generally on the Reseller's resources, market penetration, technical skill and support level, as well as Epson's need for efficient territory coverage and product availability. Epson's overall aim is to ensure that end-users of Epson inks receive the best in support, and that our products remain competitive in the marketplace.

Introduction

Epson has launched a redesigned distribution policy for its consumer ink products. This policy change best serves customers, rewards key reseller partners with continued access to select Epson Ink product, promotes quality customer service and assists Epson in maintaining its premium brand image.

Select Epson consumer ink cartridges will only be sold through an Authorized Ink Reseller network. Epson Authorized Distributors will only be allowed to sell select Epson ink products to customers that are (a) designated by Epson as an Authorized Ink Reseller, and (b) not otherwise restricted by Epson.

Program Terms and Conditions Summary

Epson resellers will have 30 days to meet the requirements to be an Authorized Premium Reseller, including agreeing to Epson's Authorized Reseller Agreement. The following is a brief summary of the key requirements to become and maintain status as an Epson Authorized Ink Reseller.

- Reseller must purchase Epson products only from an Epson Authorized Distributor
- Reseller must sell Epson Products to retail customers only and not to resellers
- Reseller must sell Epson Products only in approved geographical territories (US or Canada)
- Reseller must be separately approved by Epson to be an online retailer
- Reseller must abide by Epson's reseller requirements including: to promote and market the products, maintain
 qualified personnel and provide quality post-sale support.
- \$5,000 or more annual sales of Epson consumer ink
- Does not sell Epson ink on online third party marketplaces
- Does not promote or sell non-genuine Epson consumer ink.
